System Management Board Proposed Funding for 2017-2022 CRPs and Platforms

Purpose

This document provides, for System Council information, an updated Window 1 & 2 ('W1-2') 2017 budget request for the 2017 – 2022 CGIAR Portfolio that was approved by the System Council at its 2^{nd} meeting on 25 – 26 September 2016.

It serves as a companion document to the paper that is anticipated to be presented by the joint System Council/System Management Board Funding Allocations Working Group (meeting document SC4-2B).

Updated Budget Request for the approved 2017 – 2022 CGIAR Portfolio

- Taking note of the System Council's decisions at its 2nd meeting to approve a strong 2017 – 2022 CGIAR Portfolio comprised of 11 CGIAR Research Programs ('CRPs') and 3 Platforms Council's 2nd Meeting, <u>Appendix 1</u> sets out the total updated budget request of the System Management Board of US\$ 193.1 million, allocated between the CRPs and platforms as shown.
- 2. This amount is presented by the System Management Board on the following basis:
 - a. <u>As a starting point</u>: taking the approximately US\$ 221.1 million that represented the combined value of all proposals submitted for review by 31 July 2016, comprising 12 proposed CRPs and 3 platform proposals;
 - b. Reducing fully from that amount: US\$ 14.5 million representing the combined W1-2 value of the three elements that were not finally presented to the System Council by the System Management Board as part of the proposed 2017 2022 CGIAR Portfolio, namely:
 - i. Grain Legumes & Drylands Cereals proposal submission;
 - ii. Flagship project ('FP') 5 from the Maize proposal; and
 - iii. FP3 from the Fish proposal; and
 - c. Further reducing from that amount: US\$ 13.5 million representing the proposed W1-2 funding requests for the 5 flagships that the System Council determined would not receive W1-2 funds for 2017, with future access to W1-2 funding for each of those flagships to be determined by the System Council at a later time based on a revised submission for relevant flagships from the System Management Board. This affected: Fish FP2, FTA FP2, Livestock FP3 & FP5, and WLE FP5.

Part B – Ensuring accountability for use of W1-2 funds

3. The System Management Board recognizes that CGIAR's Funders seek assurance that a robust monitoring and evaluation framework is in place to ensure that W1-2 funding is used for strategic purposes. To that end, the System Management Board puts forward the performance matrix materials that are set out in Annex 4 of meeting document SC3-04, as the progress markers, proposed indicators and targets disaggregated to flagship level, that will provide a framework for 2017 CRP performance.
